NOTICE is hereby given that the 44th Annual General Meeting (AGM) of the Members of Gujarat Sidhee Cement Limited "the Company" will be held on **Monday, 13th August, 2018 at 10.00 a.m.** at the Registered Office of the Company, Off Veraval-Kodinar Highway, Pin - 362 276 "Sidheegram", Tal- Sutrapada, Dist. Gir Somnath, Gujarat, to transact the businesses as set out in the Notice convening the Meeting and the related Explanatory Statement thereto. The Notice convening the AGM and the Annual Report for FY 2017-18 have been dispatched / e-mailed to all Members on **20th July 2018** at their addresses / e-mail addresses registered with the Registrar & Transfer Agents.

In accordance with Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules 2014, as amended from time to time and Regulation 44(1) of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, the Company is providing to the Members the facility to cast their vote at the AGM through e-voting facility being provided by Central Depository Services (India) Limited (CDSL).

The instructions for e-voting are given in the notice of the AGM. Members are requested to note the following:-

- The Board of Directors has appointed Mr. Sachin Ahuja, Chartered Accountant and Proprietor of M/s. Sachin Ahuja & Associates, Chartered Accountants as Scrutinizer to scrutinize the remote e-voting and voting process at the AGM in a fair and transparent manner.
- Members holding shares either in physical form or in dematerialized form, as on the Cut-Off Date i.e **Tuesday, 7th August 2018** shall be eligible to exercise their right to vote by remote e-voting.
- The remote e-voting will commence on **Friday, 10th August 2018 at 5.00 p.m.** The remote e-voting
- The remote e-voting will end on **Sunday, 12th August 2018 at 9.00 a.m.** The remote e-voting module shall be disabled for voting by CDSL thereafter.
- A member may participate in the AGM even after exercising his right to vote through remote e-voting but shall not be allowed to vote again.
- In case a person has become a Member of the Company after dispatch of the Notice but before the Cut Off date i.e **Tuesday 7th August 2018**, he may obtain the User Id and password by following the procedure as mentioned in the Notice of the AGM or by sending a request at helpdesk.evoting@cdslindia.com.
- The facility of voting through Ballot Paper shall be made available at the AGM.
